APPLICATION INSTRUCTIONS:

TEST AREA: Always test ECOGUARD Daily Cleanser on a small area of the surface to be treated before overall application to determine suitability and results. Use a test location that is out of the way and not in the main area of the final area.

APPLICATION: isi GmbH ECOGUARD™ Daily Cleanser into your auto scrubber clean water tank, fitted with the ECOGUARD Daily Maintenance Cleaning Pad under the ECOGUARD Warranty. Dilute 1 Liter of Daily Cleanser to 70 L. of water for daily cleaning maintenance. For heavy duty grease removal, use up 1,5 L. of Daily Cleanser 70 Liter of water. On direct oil spills, you may pre-soak with a 1:1 mix to break down and emulsify heavy grease/oil based surface contamination.

To clean using a mop and mop bucket, saturate the mop in the recommended diluted solution, squeeze out excess material and disperse freely. Use a bucket wringer and mechanically compress out.

Once complete, use a clean water rinse to remove all contaminants embedded in the Daily Cleanser diluted solution. The use of a high speed buffing machine is recommended to obtain optimal gloss and shine once dry.

COVERAGE: Approximately 2300 m² per Liter in concentrate 1:250
